Richard Thompson Student Design and Production Exhibit and Competition

The California Section of the United States Institute for Theatre Technology announces the 2012 Richard Thompson Student Design and Production Exhibit and Competition. This competition will be held during the Section's Annual Job Fair to be held at the Seaver Theatre Complex at Pomona College in Claremont (<http://theatre.pomona.edu>) on January 21, 2012, hosted by the Pomona College Department of Theatre & Dance.

This exhibit and competition is open to currently registered students at a college, university, or high school in California. All areas of design, technical production, and stage management are included. A production is eligible if it was mounted by the student's school between January 1, 2011 and December 31, 2011.

PLEASE NOTE: Classroom projects or other theoretical projects cannot be accepted. The display and the judging criteria will be essentially the same as is used in the Kennedy Center American College Theatre Festival (<http://www.kcactf-8.org/>). This competition also will provide the students the opportunity to do a test run of their presentations if they are taking part in KC-ACTF or URTA this year or want to do so in the future.

This year, complimentary student registration for the 2012 USITT Conference in Long Beach, California, will be awarded to three participant. (These registrations will not be transferrable.) The judging will be done at the conclusion of the Job Fair by a jury selected by the officers of the Southern California Section of USITT.

Students who wish to submit an entry should register to reserve a space no later than Thursday, January 12, 2012. There is NO application fee.
